I/we apply to the Town of Parry Sound for municipal water and wastewater services at the service address noted on page 1 of this agreement. I/we agree to and understand the following:

1. To pay for these services as bills are rendered and comply with the conditions for services as set out in the Town's municipal by-laws regarding such services;
2. That the supply of municipal water and wastewater services to property are governed by the Municipal Act, 2001 and may be subject to the discontinuance of water services for non-payment and/or the transfer of arrears to the property tax roll, with priority lien status. The Town will not be held liable for any loss, damage or inconvenience resulting from services disconnected for non-payment;
3. Bills are payable on or before the due dates that appear on your bill. All accounts not paid by the due dates are subject to a late payment surcharge;
4. The Town of Parry Sound makes every effort to ensure that all billings are accurate. However, billing errors can occur and the Town reserves the right to provide correction as per the Municipal By-law;
5. Personal information on this form is collected by the Town of Parry Sound under the authority of The Municipal Act, 2001, S.O. 2001, c.25, as amended and any by-laws passed pursuant to it. Information is used to provide you with ongoing service for billing, collection and conservation, which includes the following purposes:
  - a) Establishing and maintaining responsible relations with customers including providing services, billing for services, sending notices about services, responding to customer enquiries and otherwise providing customer service;
  - b) For settlement, processing and the collection of past due accounts;
  - c) For law enforcement purposes and complying with legal requirements;
  - d) For effective water and wastewater management and provision of ongoing service to customers, including system planning and conservation planning;
